#### Sales pitch:

The arrival of young people in a situation of exile in a member country of the European Union is accompanied by numerous structural and personal challenges. Among the obstacles most frequently encountered are language barriers, socio-economic insecurity, social isolation, the complexity of administrative procedures, and difficulties in accessing education and employment. In this context, the provision of structured support is of great importance.

Supporting young exiles, particularly through tutoring, is a complex and multidimensional issue. It involves issues of a social, psychological, educational and legal nature, and requires a systemic approach based on coordinating the various players and taking into account the whole person being supported. Supporting a young person in exile involves establishing a relationship of trust and working alongside them, taking into account the different dimensions of their identity: emotional, cultural, cognitive and social.

The tutoring relationship lies at the interface of social and educational logic. It involves the acquisition of knowledge and skills, inclusion in a new environment and identity-building. In this context, the tutor is invited to adopt a "third-party educator" stance, i.e. a mediating position that makes it possible to combine various aims: learning, personal development, training and problem-solving, while respecting the pace and individual pathway of the young person being supported.

The identification of needs, the alleviation of anxieties, the transmission of reference points, as well as the co-construction of a project for the future, are all central functions of support. These aspects will be at the heart of the discussions at the symposium on support for young exiles, based on an analysis of the Erasmus+ RENT project, co-sponsored by Erasmus Expertise (France) and the University of Suceava (Romania).

An interdisciplinary and multi-faceted approach will be favoured, crossing several perspectives: analysis of European policies on education and inclusion, the socio-pedagogical approach, first-hand accounts, as well as the artistic and expressive dimensions of the experience of exile. Particular attention will be paid to the place of writing in migratory journeys, seen as a trace, a tool for subjectivisation and a vector for reconstructing identity.

Finally, the central question guiding the discussions will be: to what extent does support, in the context of exile, constitute a lever for rebuilding a life project on European territories?
